## **Policy Plan New Creation Realities Ministry**

### **Introduction**

New Creation Realities Ministry is a religious denomination based in Amsterdam and operates as a legal entity under Dutch law. This policy plan outlines the mission, objectives, and policies across various areas within the organization.

### **1. Mission and Vision**

### **3. Organizational Structure**

The leadership of the denomination consists of overseers and elders. The overseers/elders' council:

- Consists of at least 3 and at most 7 members.
- Oversees the spiritual and organizational leadership of the church.
- Appoints officials for financial management and administration.
- Makes decisions unanimously or by majority vote under the leadership of the presiding overseer.

**Deacons** are appointed for specific tasks within the local congregation, in accordance with the requirements of the New Testament.

#### **4. Membership**

Members of the denomination are individuals who:

- Accept the doctrinal foundations of the congregation.
- Support the vision and policies.
- Actively participate in the activities of the congregation.

Members are entitled to pastoral care and remain members until they voluntarily withdraw or are excluded based on biblical guidelines (e.g., in cases of serious sin or divisive behavior).

#### **5. Financial Policy**

The denomination finances its activities through:

- Voluntary tithes and offerings.
- Donations and gifts.
- Legacies and other contributions.

The financial administration:

- Is maintained transparently and reported periodically.
  - Must always provide insight into rights and obligations.
  - Is audited by the overseers/elders' council.

#### **6. Activities and Implementation**

To fulfill its mission and objectives, the denomination organizes:

- Weekly worship services and Bible studies.
  - Prayer meetings and discipleship training.
  - Evangelism and missionary activities.
  - Social and diaconal projects to support the community.
